POLICY STATEMENT

The FIU Disability Resource Center (DRC) is responsible for assisting students with obtaining appropriate and reasonable academic accommodations based on a documented disability. It is the responsibility of the student who needs accommodations to register with the FIU DRC to receive accommodations. Any student who fails to complete the registration process with DRC will not receive accommodations to meet HWCOM professional and technical standards.

Students are accountable for their performance, with or without accommodations. All technical and academic standards need to be met with or without reasonable accommodations.

SCOPE

This policy applies to all medical students.

REASON FOR POLICY

This policy provides a means by which HWCOM students with disabilities may request reasonable accommodations from the FIU Disability Resource Center (DRC).

PROCEDURE STATEMENT

Students who require accommodations must register with FIU Disability Resource Center (DRC) prior to the beginning of, or during, their first semester or as soon as a qualified or perceived disability occurs to ensure access to accommodations. Students who have documentation to support extra time or a distraction-free testing environment must request new or adjusted accommodations from the FIU DRC at least three business days before an assessment.

Once the accommodations have been approved or additional accommodation provisions have been granted by the FIU DRC, the Medical Student Disability Accommodation Committee will be notified in writing by the FIU DRC.

FIU DRC approved accommodations related to testing and evaluation will be implemented by the Office of Medical Education. Implementation of FIU DRC approved accommodations can take up to two business days.

United States Medical Licensing Exam Accommodations

Students should begin the application process to the USMLE for accommodations at least six (6) months in advance of the timeframe during which they plan to take a USMLE examination.
