The AUTHOR understands that this agreement is conditioned upon the WORK being original, and upon reasonable substantial accuracy in the text and citations as determined by the FMSRJ Editorial Board. The AUTHOR agrees to maintain reasonable communication with the FMSRJ and to consent to reasonable editorial board changes, additions and deletions. The AUTHOR understands that, should events render the content of the WORK obsolete or otherwise so untimely as to vitiate its value, the FMSRJ may cancel this contract.

I. AUTHOR'S GRANT OF RIGHTS

- A. Except as providing in Paragraphs I(C) and II(B), the AUTHOR grants to the FMSRJ the right to reproduce and distribute the WORK in the FMSRJ, in any medium the FMSRJ finds appropriate, as a contribution to a collection published by the FMSRJ.
- B. The FMSRJ's rights provided in Paragraph I(a) shall be exclusive for a period beginning when this Agreement is executed and ending one (1) year after publication of the WORK in the FMSRJ.
- C. The FMSRJ's right to reproduce the WORK includes the right to prepare a translation in English or to authorize the preparation of such a translation, but such right is subject to the AUTHOR's approval of the translation, which is not to be unreasonably withheld.
- D. After the WORK has been published in the FMSRJ, the FMSRJ shall have the right, after notification of the AUTHOR, to Authorize another party to reproduce and distribute the WORK in forms specified in Paragraph I(A).
- E. The AUTHOR grants the above rights without claim of royalties or other compensation.

II. AUTHOR'S OWNERSHIP OF COPYRIGHT AND RESERVATION OF RIGHTS

- A. The copyright in the WORK shall remain with the AUTHOR.
- B. The AUTHOR retains the rights:
 - 1. To reproduce and distribute the WORK, and to Authorize others to reproduce and distribute the WORK, in any format, to students for classroom use, at or below cost.
 - 2. To include the WORK, in whole or part, in another WORK of which AUTHOR is the sole or joint AUTHOR or editor, provided that in either circumstance the AUTHOR may not submit a work for publication that is substantially the same as the WORK to another periodical without the permission of the FMSRJ sooner than one (1) year after publication of the WORK, and provided further that such WORK identifies the AUTHOR, the FMSRJ, the volume, the number of the first page, and the year of the WORK'S publication in the FMSRJ.

3. To post the WORK, in whole or in part, on an Internet or Intranet site over which the AUTHOR has effective control provided that such WORK identifies the AUTHOR, the FMSRJ, the volume, the number of the first page and year of the WORK'S publication in the FMSRJ.

III. PUBLICATION BY OTHERS

The FMSRJ shall have the right to Authorize another party to reproduce and distribute the WORK in a form specified in Paragraph I(A), provided that such reproduction identifies the AUTHOR, the FMSRJ, the volume, the number of the first page, and the year of the WORK'S publication in the FMSRJ, and provided further that the AUTHOR has been notified by the FMSRJ of its intent to Authorize such reproduction and distribution not less than thirty (30) days prior to the grant of such Authorization and the AUTHOR has not within thirty (30) days after being notified given the FMSRJ written notice of the AUTHOR's objection to such reproduction and distribution.

IV. AUTHOR'S WARRANTIES AND UNDERTAKINGS

- A. The AUTHOR warrants that to the best of the AUTHOR's knowledge:
 - 1. The AUTHOR is the sole AUTHOR of the WORK and has the power to convey the rights granted in this Agreement.
 - 2. The WORK has not previously been published, in whole or in part.
 - 3. The WORK does not infringe the copyright or property right of another.
 - 4. The WORK does not contain matter that is defamatory, violates another's civil rights, right of privacy, right of publicity, or other legal right, or is otherwise unlawful.
- B. If the WORK reproduces any textual or graphic material that is the property of another for which permission is required, the AUTHOR shall, if requested by the FMSRJ, obtain written consent to such reproduction.

V. EDITING AND PRINTING

- A. The AUTHOR authorizes the FMSRJ to edit and revise the WORK prior to publication in the FMSRJ, but the WORK shall not be published by the FMSRJ unless it is acceptable in its final form to both the AUTHOR and the FMSRJ.
- B. Promptly after publication, the FMSRJ shall provide 1 copy of the WORK to the AUTHOR at no charge. The AUTHOR may obtain additional copies at a cost to be determined by the FMSRJ.

VI. LITIGATION

A. If a claim is asserted against the FMSRJ as a result of the AUTHOR's alleged breach of this Agreement or the warranties herein, the AUTHOR shall be promptly notified. The AUTHOR shall have the right to participate in the FMSRJ's response to and defenses against such claim, and the FMSRJ shall not settle such claim without the AUTHOR's approval. If a settlement requires the FMSRJ to make a money payment, or a money judgment is rendered against the FMSRJ, the AUTHOR shall reimburse the FMSRJ for the amount of such payment or judgment, and shall pay the cost and expenses reasonably incurred by the FMSRJ in defending against the claim.

B. The FMSRJ shall have the power, after giving notice to the AUTHOR, to initiate legal proceedings against persons or entities believed to be infringing the rights granted by the AUTHOR to the FMSRJ. The AUTHOR agrees to cooperate reasonably in the institution and maintenance of such proceedings. Damages recovered in such proceeding shall be applied first toward the FMSRJ's reasonable costs and expenses incurred in the proceedings, and the balance shall be divided equally between the AUTHOR and the FMSRJ.

VII. FINAL AGREEMENT

This Agreement constitutes the sole agreement between the AUTHOR and the FMSRJ with respect to the publication and copyright of the WORK. Any modifications of or additions to the terms of this Agreement shall be in writing.
